J O'Meara, a former President of the Conference on the Uniformity of Legislation in Canada, joined us. So did Mr. John Hearne who drafted the 1922 Irish Constitution.

My training was in very good hands. It was my good fortune to have worked under them and with all of them. I am ever in their debt. Again, I must thank Mr. Francis Bennion for permission to use material from his vast publications.

Throughout my career the works of Elmer Driedger and Reed Dickerson are constant companions. I owe so much to them.

Since November, 1974, I have been associated with the training of Parliamentary Counsel under a Scheme organised by the Commonwealth Secretariat. The Hon.
